

Important information and changes to the Financial Services Compensation Scheme (FSCS) Deposit Protection Limit

As a UK regulated institution, National Bank of Egypt (UK) Ltd is covered by the FSCS. The FSCS can pay compensation to depositors if a bank is unable to meet its financial obligations. Most customers holding deposits with banks, which include individuals and small businesses, are covered by the scheme.

Please be advised that as a scheme provided by the UK Government, the FSCS deposit protection limits are as follows:

- For individuals the limit of protection is £85,000.00 per bank, building society or credit union.
- For joint account holders each account holder will have a level of protection cover up to £85,000.00 (e.g. if two account holders, a total of £170,000.00)

The £85,000.00 limit relates to the combined amount in all the eligible depositor's accounts held with National Bank of Egypt (UK) Ltd. This includes the customers share of any joint account and not for each separate account.
